
# Absolute supremacy

The **whole** of EU law prevails over the **whole** of national law

#### National Perspective of Member States

## **Relative** supremacy

The supremacy of EU Law is admissible only with reference to **national legislation** + It is granted and **limited by constitutional law**  The Main Actors in the Evolution of the Interpretation of the Supremacy Principle: the *Dialogue*

Now art. <u>117 Cost</u> has settled the matter once and for good....but how did we get here?

The Setting: EU treaties received via statutes (*legge ordinaria*) they could be amended by a subsequent act

having the same legal footing!

lex posterior derogat priori lex specialis derogat generali The Consitutional Setting was Incompatible with the Principle of Supremacy as Envisaged by the ECJ in its <u>Costa</u> jurisprudence


